

Terms and Conditions

Definitions

Organizer - The organizer stated in the Terms and Conditions is GoEuro GmbH, Schönhauser Allee, 180, 10119 Berlin.

Participant - Participants stated in the Terms and Conditions are those sending their scholarship application to the organizer via Netquest.

Application - The application entry for the ten scholarships is the Netquest questionnaire created by the organizer and submitted by the participant. Participants who complete the questionnaire can also take part in an Instagram competition.

Instagram competition - Participants who fill out the application can enter the Instagram photo or video contest. The Instagram competition is optional. Applicants can only win one prize by organizer and therefore unable to win a scholarship and additional Instagram prize.

Participant Criteria

Participants must be of legal age in their country of residence to apply for the scholarship.

Employees of the organizer, their family members, or anyone else connected with the GoEuro scholarship is not allowed to participate.

Only one application per participant. Entries on behalf of another person will not be accepted and joint submissions are not allowed.

There are no monetary costs involved for participants to apply. There are no monetary costs for universities and colleges to be eligible for the scholarship.

All students that wish to send an application to win the GoEuro scholarship must note:

- That their university or college needs to be eligible for the scholarship first. Students can check if their university or college has already been approved by reviewing our "Eligible Universities and Colleges List" in the table on the study abroad page.

- This year's scholarship is open to students enrolled at universities in the following countries: USA, UK, Spain, Germany, Italy, Czech Republic, Poland, Netherlands, Sweden, Portugal.

- If a university or college is not mentioned on our "Eligible Universities and Colleges List", they can contact college@goeuro.com to register themselves.

- Criteria for universities & colleges to be eligible for the scholarship: They must publish news about our GoEuro European Study Abroad Scholarship on their institute's website or e-mail newsletter (screenshot will be required if it is in a newsletter).

- All participants must already be enrolled at a college or university program for the 2017/2018 academic year. Winners will be asked to submit a "Proof of Enrollment" document (PDF copy) at their current institution. They will also need to send a copy of their "Letter of Acceptance" for their study abroad course at an European institution. Only study abroad programs in EU countries and/or Schengen Area countries are qualified. Failure to submit these documents to the organizer one week after the organizer has initially notified the winner, will mean the winner's prize will be forfeited and the organizer shall be entitled to select another winner.

- In order to also enter the Instagram competition, students must select the check box in the application form and submit their Instagram account name. Then, they must post a video or an image that represents the European country they're hoping to study in. The post must be tagged with @goeuro, the hashtag #goabroad and a caption explaining WHY they dream of studying in that country. The two most inspiring videos or images will each win €500 and will be judged by EyeEm Photographer Samuel James Harries. Find us on [Instagram here](#).

User Agreement

Participants need to complete all required sections of the application for their submission to be considered valid by the organizer.

By clicking the tickbox of the application, " I accept the Terms & Conditions", the participant has read, accepted and agreed to the Terms & Conditions outlined on this page.

By including their Instagram name, students can also enter the Instagram competition. They can leave this field blank if they do not wish to enter this part and just want to apply for the scholarship.

Application Restrictions

Applications for the scholarship competition will be accepted by the organizer between **12:00 (GMT+1) Monday 25th September 2017** and **midnight (GMT+1) on Wednesday 31st January 2018**. Applications received outside this time period will not be considered.

The organizer accepts no responsibility for entries not received for reasons unrelated to the organizer.

Prizes for the Application:

The ten individual scholarships that will be awarded are:

€2,000 each

Prizes for Instagram contest:

Two individual prizes of €500 each

Only one winner will be awarded for each scholarship and Instagram contest prize. Winners are only entitled to one prize. Winners of applications will be decided from a random draw of applications received in accordance with these Terms and Conditions. The draw will be performed by a random generator computer process. Winners of the instagram contest will be chosen by third party judge, EyeEm photographer Samuel James Harries, based on the most creative picture or video with the most inspirational caption.

The winners will be notified on **Monday 5th February 2018** by the e-mail submitted in their application.

The prize money will be sent to the winners by the organizer via bank transfer. The organizer accepts no responsibility for any costs associated with delivering the prize money. The winning participants agree that all extra costs associated with delivering the winnings will be deducted from the prize money total (including but not limited to, currency conversion fees, inflation rates, bank transfer costs, tax fees). The participant agrees, that in the case of delivering the prize money, that personal details given to the organizer will be used for the only purpose of payment transfer.

Winners can use the monetary prize at their discretion. The prize is non-exchangeable, non-transferable and is not redeemable for other prizes.

Disqualification

The organizer is not responsible if for any reason the winners have not submitted their contact details correctly and therefore cannot be contacted. If for that and any other reason a winner does not reply one week from the initial notification by the organizer, the winner's prize will be forfeited and the organizer shall be entitled to select another winner in accordance with the process described above (and that winner will have to respond to notification of their win within one week or else they will also forfeit their prize). If a winner rejects their prize or the entry is invalid or in breach of these Terms and Conditions, the winner's prize will be forfeited and the organizer shall be entitled to select another winner.

False information provided by a participant during the application process will lead to disqualification, especially with regard to incorrect contact information and falsifying university or college details. Participants who manipulate the process or attempt to manipulate the process in anyway or do anything else that goes against the Terms and Conditions as stipulated will have their application disqualified.

Disqualification due to breach of Terms and Conditions may also take place after the application deadline in which case, winnings can be reclaimed.

Termination

The participant may withdraw their application and consent anytime by writing to the organizer, whereby the application and data will be deleted immediately.

Confidentiality

The personal data, provided by the participant, will not be passed on to any third party without the explicit consent of the participant and will be used by GoEuro only in order to proceed with the scholarship.

General

GoEuro will only be liable for intent and negligence, except in case of a negligent breach of an essential [contractual commitment](#). In this case the liability of GoEuro with simple negligence is limited to the predictable damage which is typical for raffles.

The limitation of liability is not valid in case of damage of life, body or health.

There is no right of appeal. An enforceable claim for the winnings or the payout in cash does not exist.

The legal framework for the conditions of this competition is the law of the Bundesrepublik Deutschland, excluding international uniform law, especially the UN Sales Convention. The legal regulations for the choice of law and for the applicability of binding rules, especially of the state, in where the consumer usually lives, remains unaffected. The legal regulations are valid for the place of jurisdiction.
